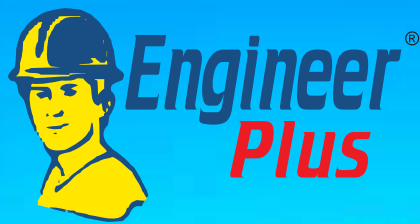

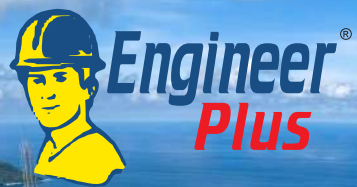

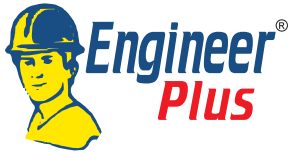

### Vacation Trip Plan for Associates/Franchises Achieving Rs. 20 Lacs/12 Lacs Revenue Target

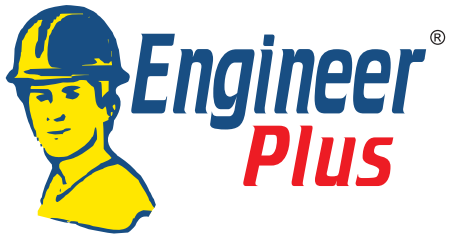
#### 1. Eligibility :

- The reimbursement will be processed within 1 month after the trip has taken place.

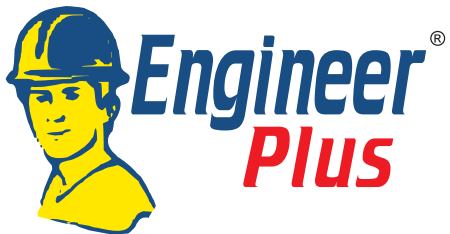
### 5. Trip Cancellation :
